- ◆ OLC is an independent non-profit law firm providing free legal aid to low income people.
- ◆ Our mission is to achieve justice for the low income communities of Oregon by providing a full range of the highest quality civil legal services.
- ◆ We do not take criminal or family law cases.
- ◆ Due to limited resources, OLC cannot take every case.
- ◆ We accept cases based upon available staff, a legal evaluation, and priorities. OLC's Board of Directors sets the priorities based on input from clients, agencies serving clients, local attorneys, judges and staff.

What kind of cases does OLC's Portland Regional Office accept?

- ◆ **Employment**
 - Unpaid wages
 - Unsafe work conditions
 - Sexual harassment
 - Discrimination (being treated differently because of race, disability, national origin, gender, religion, or having children, etc.)
- ◆ **Housing**
 - Eviction
 - Retaliation
 - Major repair problems
 - Sexual harassment
 - Discrimination
- ◆ **Public benefits**
 - TANF, SNAP, unemployment, medical insurance, and other problems with government assistance programs. **Please call Public Benefits Hotline, 1-800-520-5292, for screening first.**
- ◆ **Education and other civil rights**
 - Special education problems
 - Discriminatory school discipline
 - Different treatment by local, state, or federal government based on race, religion, disability, gender, or other vulnerable status

 - Limited assistance, specific cases, underserved geographic areas
- ◆ **Consumer fraud and scams**
